He has written (and co-written) six energy management books, is Vice Chair at Energy Managers' Association, and Advisory Board member of Resource Efficiency research (EPOS) at University of Gent, 2degrees Network, and Institute of Chemical Engineers' Energy Leadership Forum. Kit works with businesses to achieve real-and-achievable energy savings using high-return low-investment strategies and has 18 years of hands-on energy management experience in a range of commercial and industrial companies across four continents.

From a standards perspective, he was the convener of ISO 50002, EN 16247 and PAS 51215. He is a lead auditor, trainer, and UK's principal expert for ISO 50001, and ISO 50003. Currently, Kit sits on ISO's JTCG committee writing the integrated use of management systems handbook.
