### SYNOPSIS

The title of this paper contains an example of implementation and current practice at the industries on how we want to go beyond legal compliance. The presentation provides the safety and health system approach and review of OSH management and effective ways in managing OSH. The paper produced a conceptual framework on how to manage OSH systematically and more effectively beyond legal. This framework was used to change the current practise to the proactive practices that have five goals:

- to identify sets of practices with effective management of OSH;
- to improve safety outcomes in workplaces
- to define a leadership styles and approach
- to explain the context features that have greatest influence on establishments' commitment to effective management of OSH;
- to understand the similarities or differences between the employers' and employee representatives' perspectives;
