The Arbitration lecture will deal with arbitration agreement, composition and appointment of arbitrators, tribunal's jurisdiction and conduct of proceedings, award and termination of proceedings, recognition and enforcement of awards.

As for Adjudication, there is also the issue of appointment of adjudicators, the Adjudication process of payment disputes, enforcement of Adjudication Decision, and in general immunity of Adjudicators and the prohibitory conditional payment terms.

Actual and sanitized cases will be used to illustrate the practicality of the 2 processes.

The workshop will be led by and conducted by a distinguished panel of experienced arbitrators and adjudicators. The participants will no doubt benefit from learning about the lectures and hearing from the practitioners' practical experiences through examples and case studies.
