SYNOPSIS**Contractors All Risks (CAR) Insurance**

It provides a very wide and comprehensive insurance cover to all parties involved in a project. In respect of any sort of contingency from the moment the material is unloaded at the site of the project and continues during storage, physical erection, commissioning, testing and maintenance.

Scope of Cover

It covers all physical losses or damage as under:-

- Fire, lightning, theft and burglary
- Impact from falling objects, collision, failure of changes or tackles
- Failure of safety devices, leakage of electricity, insulation failure, short circuit, explosion
- Carelessness, negligence, fault in erection, strike and riots
- Storm, tempest, flood, landslide, rockslide, earthquake

Objective of the Talk

- To understand how the project policy works
- To minimise the risks of losses at the project site
- To be aware of the claim procedure should a claim materializes
