Since the publication of the Third Edition of the Main Contracts for Civil Engineering and the Mechanical and Electrical in early 2017, the IEM Subcommittee on Engineering Contracts embarked on re-write the IEM Sub-Contract which was already more than 25 years old as it was first published in May 1990. The IEM Subcommittee on Engineering Contracts mandate was to develop a new IEM Sub-Contract that will be in line with the 2017 edition of the Main Contracts. The IEM Sub-Contract underwent numerous drafts over 5 year's period, culminating in the publication of the new IEM Sub-Contract in December 2017. The evening event is to launch the new IEM Sub-Contract and to give an introduction and overview of the salient provisions of the new IEM Sub-Contract.
