

GUIDELINES FOR IEM ENGINEERING HALL OF FAME AWARD

The Sub Committee of Engineering Hall of Fame under the auspices of the Standing Committee on Professional Practice is proud to invite nominations for the IEM Engineering Hall of Fame Award.

It is timely and expedient to induct and to record the accomplishments of engineers in the country who have or had demonstrated particularly outstanding professional achievements and provided excellent services to the Institution, the engineering industry and the Nation.

The IEM Engineering Hall of Fame is established with the aim to confer recognition and to celebrate the accomplishments of members of the IEM;

- Who have demonstrated out-standing professional achievements.
- Who have made significant contributions to the engineering profession, the Institution of Engineers, Malaysia (IEM) and the Nation.
- Who have rendered valuable service to the Community.

The Engineering Hall of Fame will serve as the focal point or showcase of outstanding Malaysian engineers, past and present, who had or have made great contributions to the engineering profession and to the quality of life in Malaysia. Engineers honoured in the Engineering Hall of Fame will also serve as a beacon and as role models for young engineers as well as create greater interest in engineering in general and awareness of the contributions made by outstanding engineers in the country.

Nominations for the Award are opened to Malaysian citizens who are or have been Corporate Members of the IEM:-

- Invitation for nominations will be announced in the IEM Bulletin and Website for receipt of nominations on 1 March each year.
- Nominations shall be made through three (3) Corporate Members of IEM with at least one who is a Fellow member, as the proposer.
- Each nomination shall be made on a prescribed form and accompanied by a brief write-up giving details of the professional achievements, the contributions made and the services rendered.
- The write-up shall be on A4 size paper and not exceeding 2000 words, with not more than three (3) copies of supporting documents/photographs.

The following basis criteria of the Award shall be considered mainly on significant engineering achievements through the use of engineering principles and applications: and service to the Community.

a) Professional Achievement (60%)

The nominee has/had demonstrated significant engineering achievements, provided significant guidance in new and developing fields of engineering based on technology, and/or has/had managed or directed an organization making noteworthy contributions in design, manufacturing, production or service through the uses of engineering principles and applications.

b) Service to the Profession (25%)

The nominee has/had contributed significantly to the engineering profession.

c) Service to the Community (15%)

The nominee has/had accomplished significant community service activities, or has/had provided noteworthy governmental communities etc.

The above will be based on a total of 100% or 100 marks.
