
In response to feedback received from members, we would like to inform that *IEM had recently written to the Ministry of Works and Ministry of International Trade and Industry (MITI) to seek their consideration to allow consulting engineers to operate during the MCO subject to complying with conditions set by Malaysian National Security Council (MKN). We are happy to inform that the Ministry of Works had been very supportive of <i>IEM's*, and they had sent an official letter to MKN requesting MKN's consideration of *IEM's* request.

We would like to take this opportunity to thank Yang Berhormat Dato' Sri Haji Fadillah bin Haji Yusof the Senior Minister, Ministry of Works for his upmost support. We will you update on further developments once there is response from MKN.
