

IEM'S AWARD

FOR

CONTRIBUTION TO THE <u>ENGINEERING INDUSTRY IN MALAYSIA</u>

GUIDELINES AND CRITERIA

The Award is conferred as recognition of the significant contributions made to the <u>Engineering Industry in Malaysia</u>. The Award is given to an Organisation or Company that :

- Contributed to the 'Advancement of Engineering' in Malaysia, and/or
- Designed and constructed an original engineering device or system of merit and applicability to industry

A. AWARD SUBMISSION MECHANISM

- The Organising Committee / designated IEM Council, Excomm, Technical Divisions, Special Interest Groups or Sections members will approach these Organisations / Companies to nominate them for the Award.
- <u>All the Award Nominees shall buy table/s at the IEM's Annual Dinner. Annual Dinner Table categories to be purchased by all the winners is stated (at item E).</u>
- Organisations / Companies who had won the Award previously (under any categories), are not eligible to be nominated for any categories, for the next three (3) years. This is too encouraged and allows other Organisations / Companies to be nominated.
- The Evaluation / Judging Committee shall make their selection based on specific criteria. The winner would be announced at the IEM's Annual Dinner.

B. CRITERIA FOR THE AWARD

The basis for the Award shall be engineering achievements that demonstrate significant contribution to the progress of engineering and the quality of life both in Malaysia or Internationally.

- The Organisations / Companies to be recognised should come from sectors that are important to the Engineering Industry at that material point in time.
- The Organisations / Companies had contributed to the Advancement of Engineering in Malaysia or Internationally

• Each proposer can nominate an Organisation / Company who has performed the best and influenced the industry for the year

C. AWARD COMMITTEE

- The Awards Committee may refer to additional materials in considering the merits of the nominee. The Award shall be made by the Council upon the recommendation of the Awards Committee.
- Not less than two third (2/3) majority vote of the Awards Committee is necessary for a recommendation of an award to be forwarded to Council. When presented to Council for approval, a simple majority to approve the project would be sufficient.
- The Chairman of Activities shall be the Chairman of Judging Committee. Few Outside Members among the industry players shall be invited as the Jury Committee (invitees to be determined later).

D. THE AWARD'S WINNERS CATEGORIES

The Award's Winners are divided to THREE (3);

- PINNACLE Award > 1st Placing Champion
- TRAILBLAZER Award > 2nd Placing 1st Runner Up
- CATALYST Award > 3rd Placing 2nd Runner Up

E. AWARDS WINNERS TABLE PURCHASE

The following table categories are to be purchased by each Award Winners;

- PINNACLE Award > 1st Placing Champion (Annual Dinner Table to purchase shall be PLATINUM or DIAMOND category ONLY)
- TRAILBLAZER Award > 2nd Placing 1st Runner Up (Annual Dinner Table to purchase shall be PLATINUM or DIAMOND or GOLD category ONLY)
- Catalyst Award > 3rd Placing 2nd Runner Up (Annual Dinner Table to purchase shall be PLATINUM or DIAMOND or GOLD or SILVER category ONLY)

THE AWARD

- The Award is in the form of a specially designed Trophy / plaque and a certificate.
- The Award shall be presented during IEM's Annual Dinner and Awards Nite.
