# SYNOPSIS

In Malaysia, Environmental, Social, and Governance (ESG) reporting is increasingly important. Bursa Malaysia has mandated that all public listed companies (“PLC”) is compulsory to disclose their sustainability inclusive of past 3 years data from the financial year end 2023 onwards as part of the listing requirements. Although currently, the requirements for mandatory sustainable reporting are only mandated for public listed company, the Small to Medium Enterprises (SMEs) need to start to adopt sustainable reporting to identify and manage sustainability risk. The course aims to provide insight on ESG disclosure and Sustainable Reporting in Malaysia and provide guidance in preparing Sustainable Report that is inline with local and international standards.
