### Introduction

The talk will cover the different routes to obtaining a PE status and also the latest requisites for the interview. The participants shall be advised on issues pertaining to preparation and submission of the required documents, as well as the latest regulations involved.

- To create awareness on the latest regulations for entry and submissions of documents for the Professional Engineer’s Interview;
- To advise potential Professional Engineer candidates on the issues pertaining to the details of the required documents;
- To advise and provide hands-on guidance on the preparation of documents for professional assessment examination (PAE); and
- To advise on the current issues on the regulations for the Professional Engineer’s Interview.
