SYNOPSIS

The development of industrial and employment legislation commenced in this country in about 1878, accelerating after 1948, and now is well developed, however such accelerated development has also led to conflicting provisions in legislation.

A sound knowledge and application of industrial and employment legislation is not only relevant but essential for all those in management and supervisory positions. This will therefore also apply to engineers. Non-compliance to relevant industrial and employment legislation can lead to civil and in some case to criminal liability. The penalty in some cases is severe.

This talk will commence with a brief introduction:

To the gradual development, a piece at a time, of such legislation from about 1878 and the Interpretation Act which defines the meaning of and authority of specific words, terms and authorities.

The Occupational Safety and Health Act 1994 which is now the principal Act in respect to Occupational Safety and Health, and which applies to all those at work and therefore includes engineers will be dealt in some detail.
