However, a new industrial revolution is on the horizon – known as Industrie 4.0 in Germany, or the fourth Industrial Revolution is other parts of the world, a holistic change towards the approach of process automation has been put forward; especially in the area of communication, process optimization, virtualization, securities as well as system wide integration.
