## **SYNOPSIS**

During the last decade, there have been several green building rating tools developed or proposed for use in Malaysia. These tools include GBI, GreenRE, pH JKR, Green Seal Melaka, MyCREST and CASBEE Building. As such, this presentation aims at clarifying the following key questions: Is there a clear differentiation of these rating tools? Will the coexistence of local rating tools enhance green building practices or rather confuse the market? It is hoped that this presentation will provide a better understanding of these tools' similarities and differences as well as a guide for practitioners to decide on the tools that best suit their purposes.
