SYNOPSIS 1

Electrical Safety Legislation Updates – Amendment of Electricity Supply Act 1990 with respect to improving Safety Practices Abstract

Act and Regulation need to be reviewed from time to time, enhanced and streamlined with the development and practice in the electricity supply industry. The Electricity Supply (Amendment) Act 2015 also know as Act A1501 was passed by parliament in July 2015 and came into forced on the 1st Jan 2016. Four major aspect have been enhanced in order for more effective regulatory and enforcement activities to be carry out by Energy Commission that's government framework, safety practices through codes of practice, protection of consumer interest and application of latest technology. Apart from these, a heftier penalties for offence have been imposed. In safety aspect, the Energy Commission will be more involved in the regulation of safety management practices via the implementation of safety codes.

His first carrier after graduation started as an electrical engineer, responsible for designing hospital buildings for government project in Public Work Department. After one year in Public Work Department, he was transferred to the Department of Electricity and Gas Supply Malaysia as an Assistant Director overseeing and monitoring the electricity supply industry in Malaysia. In 2001, he joined Energy Commission also as an Assistant Director and in 2007 he was promoted to become Regional Head at Sandakan office regulating electricity supply in East Coast of Sabah. After nearly 5 years in Sandakan Sabah, he was promoted to become the Director of Energy Management and Industry Development Department at Putrajaya Head Quarters. Under this department, he is responsible for overseeing the development of energy resources of the country, energy efficiency activities which includes demand side management, setting up of regulatory framework for MEPS and ESCO and etc. Under this department he also coordinated energy information activities such as statistics and data management and also involved in the industry development activities.

Since January 2015, he has been tasked to lead the Department of Electrical Safety Regulation in charge of electrical safety in the activities of electricity generation, transmission and distribution among others, issuance of certificates of competency and accreditation of institution for competent person, electrical equipment approval, development of electrical safety standard/guidelines and establish policies in the aspect of electrical safety.
