SYNOPSIS

Alfa Laval is a leading global provider of specialized products and engineering solutions. Their equipment, systems and services help to heat, cool, separate and transport products such as oil, water, chemicals, beverages, foodstuffs, starch and pharmaceuticals. This talk specifically covers Ballast Water Treatment System (PureBallast) and Exhaust Gas Cleaning System (PureSOx) in marine engineering application.

PureBallast is an automated inline treatment system for the biological disinfection of ballast water. Operating without chemical, it combines initial filtration with an enhanced form of UV treatment to remove organisms in accordance with IMO and USCG limits.

PureSOx is a scrubber system. SOx has been at sea since 2009, reliably cleaning main and auxiliary engine exhaust gas to Emission Control Areas (ECA) compliance level. It has been installed to serve the purpose for a vessel with as large as 28 MW main engine.

BIODATA OF SPEAKER

Mr. Goh Boon Guan has 16 years of experience in marine engineering and marine equipment. He graduated from Ngee Ann Polytechnic, Singapore with Diploma in Shipbuilding & Offshore Engineering specialized in Offshore Technology in1996. He obtained Degree of Bachelor of Science with Honours from National University of Ireland in 2002. He pursued further to obtain his Master of Business Administration with Merits from National University of Wolverhampton (UK) in 2014.
