Synopsis

The revised PI process is not a new PI process. It is the **revised version** of the existing PI Process in that the structure of the existing PI Process remains the same, consisting of:

- Part 1: Documentary review of competency evidence to assess Applicant's eligibility and readiness for Professional Interview.
- Part 2: In-person assessment of Candidate that consists of face-to-face oral interview as well as writing two essays
- The revision aims to **enhance** existing PI Process, where appropriate.
 - Current Application Form
 - o Assessment Method
