- Registration of Engineers Act (1967) [REA]. Malaysia has be amended for the purpose of liberalization by 31st July 2015.
- How REA (of the 2015 amended version) related to ASEAN Economic Community (AEC).
- The various implications (of the REA 2015 amended version) for Graduate Engineers; those who aspire to be certified as Professional Engineers practicing engineering and those to be licensed for Engineering Practice in Malaysia.
