SYNOPSIS

The Energy Audit Conditional Grant (EACG) project was initiated by the Ministry of Energy, Green Technology and Water (KeTTHA) under the Eleventh Malaysia Plan (RMK-11). The project will be implemented for three years, starting from 2016 to 2018. Malaysian Green Technology Cooperation (MGTC) has been appointed as Implementing Agency to manage and monitor the project for industrial sectors, whilst the commercial sector will be managed by SEDA. The main purpose of the project is to promote energy efficiency practices and to reduce greenhouse gases (GHG) emission.

Objectives :

- To create awareness on the importance of energy auditing that is a part of energy efficiency and conservation;
- To provide the fund for industries to implement energy audit to assess their electrical energy usage and establishing a baseline
- To reduce the energy consumption of the industrial sector thus reducing their operational cost
- To reduce the emissions of greenhouse gases from energy consumption
- To enhance capacity building in the field of energy auditing
